GENERAL DECREE

Crux spes nobis

The Cross gives us hope because it signifies the desire of Jesus to bear, in our place, the punishment for our sins, in short, to save us. Therefore, during this Jubilee of Hope, I call upon all the Faithful of the Diocese of Saint Cloud, by pilgrimages and visits to sacred spaces; by prayers and works of mercy; to bear the burdens of our neighbors, both those here on earth and those being purified on the threshold of Heaven.

To that end, having received special faculties from the Sacred Penitentiary, **I hereby exhort the faithful to carry out any of the following acts to obtain, under the usual conditions, a Plenary Indulgence:**

§1 A pilgrimage or at least a pious visit to any of the following sacred places - the Cathedral of St. Mary; the Shrine of St. Cloud in the Cathedral of St. Mary; the Grasshopper Chapel in Cold Spring; the Shrine of St. Odilia in Onamia; the Shrine of St. Peregrine in Colledgeville; the Shrine of the Divine Mercy in Sauk Centre; the Chapel of the Sacred Heart, oratory of the Franciscan Sisters of Little Falls; the Chapel of the Sacred Heart, Oratory of the Benedictine Sisters in St. Joseph; the Oratory in the Poor Clare Monastery in Sauk Rapids; any church of your Area Catholic Community which you have not yet visited.

Pilgrimages should be marked by a spirit of prayer and reflection while on the journey and, at the destination, should include the celebration of Mass; or a celebration of the Word of God; or a penitential celebration culminating in the opportunity for individual confession and absolution; or praying the Liturgy of the Hours, the Way of the Cross, or the Rosary.

Pious visits should include at least ten minutes of prayer and meditation before the Blessed Sacrament, concluding with the Our Father, the Creed, and the Hail Mary or other Marian invocations.

Those who, because of illness, vows, or other grave cause find it impossible to participate in these pilgrimages and pious visits may still obtain the Plenary Indulgence if, even apart from the usual conditions, they are repentant of sin, pray the Our Father, the Creed, and at least one other prayer, and join themselves in spirit to those making the pilgrimages and pious visits. For their part, pilgrims, pious visitors, and those responsible for sacred places, while being careful not to disrupt sacred celebrations, should use modern means of communication (texts, phone calls, broadcasts via internet, etc.) to enable the homebound and others to better participate.

§2 An act of charity - visiting those in need or difficulty, such as the homebound, prisoners, or the ill; fasting for a day from virtual distractions such as media and social networks; making a donation of time or treasure to the poor, to works of the Church, or to the service of the whole human community; any of the Corporal or Spiritual Works of Mercy.

An Extraordinary Opportunity for the Jubilee Year - Two Plenary Indulgences a Day

As a generous grace for this Jubilee, the Holy Father has permitted that, contrary to the usual rule that allows the reception of only one Plenary Indulgence a day, each of the faithful may, with a second reception of Holy Communion in the context of a Eucharistic Liturgy and the completion of a second act to which a Plenary Indulgence is attached, apply that indulgence to the dead.

This decree is promulgated by publication in the Central Minnesota Catholic; it is effective from December 24, 2024, through January 6, 2026.

THIRTY-FOURTH SUNDAY OF ORDINARY TIME

First Reading:

His dominion is an everlasting dominion that shall not be taken away, his kingship shall not be destroyed.

Psalm:

The Lord is king; he is robed in majesty.

Second Reading:

To him who loves us and has freed us from our sins by his blood, who has made us into a kingdom, priests for his God and Father, to him be glory and power forever and ever.

Gospel:

Jesus answered, "You say I am a king. For this I was born and for this I came into the world, to testify to the truth."

Gospel Meditation:

When I was a young boy in Burlington, Vermont, my dad had a good friend named Phil who owned a sporting goods store. I loved sports, so meandering the treasure-filled aisles was an unmitigated joy. One afternoon, we were shopping for a baseball glove. Dad said to me, "Hey Johnny, see that man who just walked into the store? *That's* Phil." I remember being fascinated and a little terrified. I recall thinking, "That man right there is in charge of *everything* in this store!" He reigned over every ball, sneaker, jersey, and sweatshirt. Phil became a family friend. And he was a good owner. The store flourished, and I found myself even more at peace every time I went there. I felt a new hope and even responsibility for the store to flourish.

To say that Christ is the King of the Universe means that Jesus has absolute authority over everything in it. It should fill us with awe and fascination. He is in charge. The world and everything in it are his. Knowing that he knows and loves us should make us also feel a deep peace at being a part of his universe. This leads us to want his kingdom to flourish, to play some responsible role in it.

We advance his kingdom by promoting the truth. "**Everyone who is of the truth hears my voice,**" Christ the King proclaims. In Phil's store, it was about the truth of athletics. In our world, it's all about the truth of all creation, especially the dignity of the human person, made by and for our loving God. Let's rejoice that we know the true king and commit to the flourishing of his kingdom.

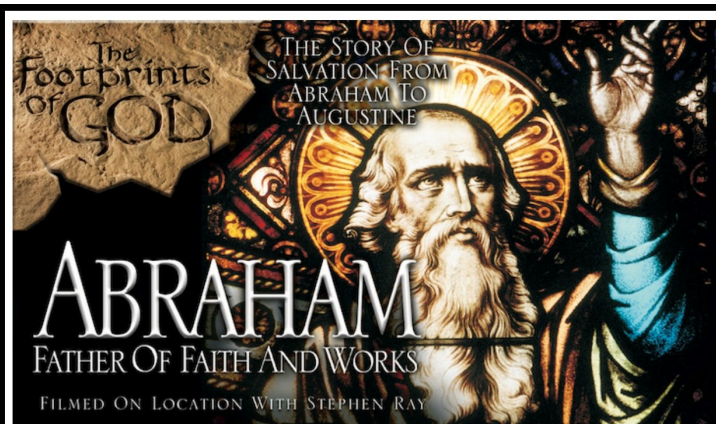

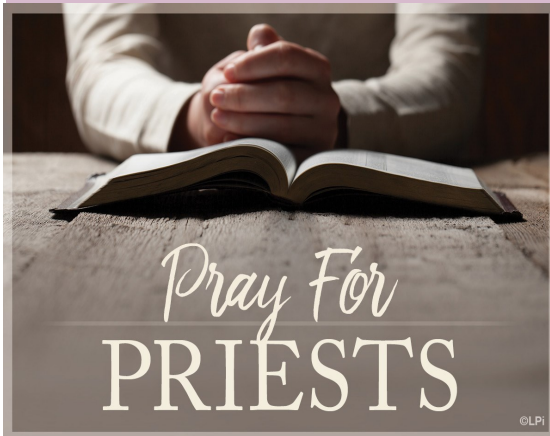
